## THE CITY OF OXFORD (OFF-STREET PARKING PLACES) (VARIATION No.1 2023) ORDER 2011

The Oxford City Council ("The Council") in exercise of its powers under Sections 32, 35 and 124(1) (c) and (d) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and with the consent of the Oxfordshire County Council in accordance with Section 39(3) of the Act of 1984 makes the following Order:-

- This Order shall come into operation on 9<sup>th</sup> November 2023 and may be cited as "The City of Oxford (Off-street Parking Places) (Variation No.1 2023) Order 2011"
- 2. The City of Oxford (Off-street Parking Places) Order 2011 is hereby varied as follows:-
  - (a) The following expressions are added to PART 1 Implementation, Citation, Revocations and Definitions at Article 2(2) in appropriate alphabetical order:-

"cashless payment" means electronic, digital or other means as described at a payment and information point at the parking place and may utilise payment by credit or debit card or similar or by adopted pay by phone provider or other automatic payment system and for which an additional charge may be levied;

"Payment and information point" means a facility at a parking place to convey advice on means of payment of a parking charge and information concerning parking place controls; "Parking Session" means where a payment to park has been made according to the tariff for the parking place and for the time specified according to the payment made;

"Virtual permit" means a permit created electronically and stored on a computer database and which may be accessed by an authorised Council Officer for the purpose of confirming payment has been made for the parking in which the vehicle has been observed.

- (c) Part II, Use of Parking Places (iii) Article 35 is deleted and the following inserted in its place:-
  - 35. Subject to Article 37(b), the charge referred to in Article 34(1) shall be payable upon parking of a vehicle by any available method of payment as described at a payment and information point at the parking place including but not limited to cashless payment and use of an adopted pay by phone provider or use of an adopted ANPR automatic payment system.
- (d) Part II, Use of Parking Places (iii) Article 36 is deleted and the following inserted its place:-
  - 36. Upon payment of the charge for the vehicle the driver of it shall exhibit in the relevant position on the vehicle a ticket issued by the ticket machine where required.

- (e) The following is inserted in to Article 37 of Part II, Use of Parking Places (iii):-
  - 37 (c) Using the Council's adopted pay by phone provider or by using the Council's adopted ANPR automatic payment system.
