- 1. This is the form of notice required to advertise an application for
 - A <u>new</u> Club Premises Certificate.
- 2. Different forms must be used to advertise an application for any of the following:
 - Variation of a Club Premises Certificate
 - <u>Variation</u> of a Premises Licence
 - A <u>new</u> Premises Licence
 - A Provisional Statement (for premises under construction)

Note for users of this notice

- 3. A copy of the completed notice must APPEAR ONCE in a local paper circulating in the vicinity of the application premises WITHIN 10 WORKING DAYS OF THE DATE OF YOUR APPLICATION.
- 4. Club = name of the club, whether or not you have appointed an agent to apply on your behalf.
- 5. **Club address =** to identify the application premises.
- 6. **dd / mm / 2005 =** 28 days after the date the application was made. (NOT 28 days after the notice in the newspaper).
- 7. **Qualifying club activities =** The whole of your proposed operation is subject to consultation, so you should describe it briefly here.
- 8. Ideally, the wording that is **specific to your notice** should appear in **bold** (PTO)
