

What is an SPD and what does this one do?

- An SPD is a Supplementary Planning Document that provides further detailed advice and guidance on adopted Local Plan policies. In this case it includes principally the West End and Osney Mead Area of Change (AOC 1), West End Sites (SP 1) and Osney Mead (SP2);
- The main body of the SPD summarises and explains how to use and apply the principles of the Spatial Framework and Design Guide in developing and assessing proposals.
- The SPD explains what is needed in different areas or types of area in the West End and Osney Mead in order to meet the individual strategies, and pulling in the relevant details of the Design Guide.
- For all sites this can be used to identify the parts of the strategy and design guide advice that is most relevant


How did we get here?

- West End AAP and Design Code adopted in 2008.
- More recently identified through Area of Change and site allocations policies in Local Plan 2036.
- Commenced work on new WE SPD beginning with consultation 2021 setting out initial thoughts on vision for the transformation of the area.
- Levitt Bernstein (Urban Designers) appointed as consultants working on the Spatial Framework and Design Guide (both incorporated as appendices to the SPD). Carried out an extensive piece of work throughout 2021-22 informing SPD development including:
 - Analysis of the opportunities, constraints for the area
 - Developing vision and key strategies/design principles for future of area
 - Engaging with landowners throughout

Key objectives and intended benefits of the SPD

- Sets out the scope and parameters for development proposals;
- Sets out a clear vision for the West End and Osney Mead Area and how to realise the ambition;
- To help decision makers assess planning applications in terms of their contribution to achieving the vision for the Area of Change (Policy ACC 1);
- Helps to unlock sites by identifying infrastructure needs generated by the cumulative developments of the area and sets out how they can best be delivered;
- To enable development at Osney Mead by meeting the policy requirement for a masterplan for the site. The SPD provides specific guidance within an overarching framework for development to consider the site as a whole and to inform the future masterplanning work;
- Provides continuity.




Core strategy 2 - Movement

- 5 Create a network of routes which promote active travel as the first choice
- 6 Improve integration of public transport with walking, cycling, and micromobility
- 7 Improve connections to nearby green and open spaces and better integrate them







- The public consultation runs for 6 weeks from 29th June to 10th August;
- The public comments received will be summarised and the key issues highlighted together with the proposed changes to be made to the SPD in response
- A report will be taken to Cabinet in September / October 2022. This report
 will set out these issues and how the SPD has been amended in response.
 Cabinet will be asked to carefully consider these maters and the adoption of
 the revised SPD will be sought.
