## Policy G5

Q4: This Policy establishes additional requirements beyond habitat creation to achieve Biodiversity Net Gain (BNG) in line with national requirements. The Policy requires major development to introduce features to improve the environment for priority species through new resources attached to new built development. These requirements need to be site, and scheme specific and responsive to local features and the built development that is proposed to ensure that it is suitable for the environment that it is in.

The Council should be conscious of the Government's guidance in relation to BNG where Authority's seek higher BNG quantums over the 10% statutory requirement, particularly Paragraph: 005 Reference ID: 74-005-2023 where it states that:

Plan-makers may seek a higher percentage than the statutory objective of 10% biodiversity net gain, either on an area-wide basis or for specific allocations for development. However, such policies will need to be evidenced including as to local need for a higher percentage, local opportunities for a higher percentage and any impacts on viability for development. Consideration will also need to be given to how the policy will be implemented.

Q5: Logicor consider that this Policy should be amended or removed from the Plan, unless additional robust justification is provided in support of the policy's requirements, in accordance with the draft national policy guidance pursuant to addition Biodiversity Net Gain (BNG) requirements.

Logicor remain concerned that the significant and potentially duplicate requirements of Policies G2 to G5, whilst commendable, results in an unjustified and inappropriately prohibitive approach to achieving ecological enhancement and biodiversity gains on sites in Oxford.
