Many thanks for meeting with us on Wednesday, it was helpful to go through a bit of your response and discuss things in general. As promised, attached is a Word doc with the table where we have pulled out all of your comments from your response and drafted some initial responses to them - it includes where we propose to look into things further, propose changes to the submission plan, or where we feel a change is not warranted on the basis of further explaining our thinking.

Happy to hear that generally you are okay with what we have proposed in the Local Plan. Whilst we weren't able to get through everything on Weds, I think the key area to resolve is your comments around the HRA - we have tried to look into this a bit more following the discussion and have set out some comments in the table - but if you have any written up comments following your review of the additional material we shared since the initial consultation, would appreciate if you can share with us to help us ensure we resolve your concerns.

Proposed next steps

Moving forward, we are keen to get to a place where we are able to have resolved your concerns by the time we submit the plan (and to document how we have worked together on this via a statement of common ground). In addition to any specific comments on HRA I mention above, it would be useful if you can cast your eyes through the attached and perhaps flag back to us where you disagree or wish for further clarification. To save you time, suggest you perhaps just leave anything you are happy with as it is and we will take that as agreement (rather than you responding on every line in the table). Instead, just focus on commenting on anything where you want to discuss further (perhaps either mark up the table with comments or tracked changes, however is easiest).

Once we've heard back from you on these proposed responses, I'd suggest we could then have a follow up meeting/call to discuss any remaining outstanding issues as we want to try and ensure we get to a place of agreement between us before submission. In meantime, I will start drafting up a simple statement of common ground which documents our discussions together for the inspector and refers to this table in an appendix for the finer detail of how we've responded to your feedback. Will of course share that with you in due course.
