#### **Executive Summary**

The Oxford Playing Pitch Strategy (PPS) has been developed using best practice guidance and methodology from Sport England. It assesses current and future demand over the next 16 years and provides a robust framework for resource prioritisation and informed planning decisions. The COVID-19 pandemic has shown that the value and impact of our green spaces for our communities has never been greater for mental, physical and social wellbeing. It is key that we continue to take advantage of the benefits that sport and physical activity can bring; the power it has to unite communities around key agendas such as tackling climate change and racism and the role our pitches and facilities have in reducing health inequalities and inactivity.

In developing the strategy key partners were involved at all stages through a representative Steering Group which included Sport England, National Governing Bodies of Sport (NGBs), Universities, the local Playing Fields Association and City Council employees from the Active Communities and Planning departments.

Further consultation was carried out with local schools, clubs and other sports that utilise the city's playing pitches so that the strategy incorporates all sectors and develops its recommendations based on facilities that are accessible to the community.

Following Sport England's <u>five stage process</u>; data that evidenced supply and demand of pitch usage was collected as well as views on the quality of pitch and ancillary stock provision. This was then assessed to determine how well the needs of the current and future population were being met and from this a clear Action Plan was drafted.

This data was collected between 2018-2019, but when the global COVID-19 pandemic struck in early 2020, the final development of the strategy was delayed. The Steering Group ensured any known, significant changes to this data and the local sporting landscape were incorporated in 2021 before completion of the strategy to ensure the recommendations and actions were still relevant. The annual review will enable us to adapt the results to the latest census data as well.

The objectives of the strategy are:

- 1. To gather the best available supply and demand data on playing pitches and other outdoor sports facilities.
- 2. To assess the supply and demand data in line with available national guidance and identified good practice.
- 3. To ensure a good level of consultation with key parties throughout the development of the strategy.
- 4. To provide a robust evidence base, which can be used by a range of Council departments and other parties to help protect and improve the provision of playing pitches and other outdoor sports facilities.
- 5. To establish a clear prioritised list of actions, which will help to maintain and increase participation levels in sport and physical activity. We will also target those who are not participating as well as our diverse communities within the City and ensure the efficient use of resources.
- 6. To establish clear prioritised infrastructure requirements, including where new facilities are required and existing facilities should be enhanced. Helping to support healthy place shaping within the city and aligning with the Council's climate emergency agenda.
- 7. To identify and promote good practice regarding the provision, management and maintenance of playing pitches in the city.
- 8. To establish a process to ensure the regular review and update of the strategy and the information on which it is based.

The strategy aligns with other key Council documents including our Green Spaces Strategy, our emerging Thriving Communities

Strategy and the Council's corporate plan.

In addition, by working collaboratively the strategy links to the Strategic Plans of the NGBs of the sports that are the main pitch users in the city. Further detail on these can be found in Appendix 13.

The main deduction from the strategy is that there is currently some shortage of playing pitch provision in Oxford and in particular pitches that have secured community use. There is current unmet demand across both football Natural Turf Pitches (NTPs) and Artificial Grass Pitches (AGPs), but better use of existing provision and the planned 3G developments would mitigate this. There is also some unmet demand for Rugby Union NTPs for mini and seniors, but by improving pitch quality and with the additional pitch planned at Oxford Harlequins RFC this would again be mitigated. For hockey there is a small amount of weekday and weekend unmet demand that could be met with better use of existing provision and increased access to educational sites. All current demand for Cricket NTPs and AGPs is being met in the city and any future demand could be mitigated through increased access to educational sites through securing Community Use Agreements (CUAs).

Given this conclusion the assessment suggests that all existing provision within the city should be protected. The strategy does not however necessarily suggest that additional new pitches are required to meet the shortfall, as once you add back in those unsecured pitches that have community use or sites that are interested in starting to offer community use, plus planned 3G developments; there appears to be adequate provision for all sports. The aim of the Steering Group therefore should be to continue to look to secure CUAs with other providers of playing pitches such as educational sites; to not only meet the current demand, but also future proof against the projected significant increase in demand for cricket matches and football training.

It is important to note that any loss of provision would place greater pressure on the other remaining facilities. Where development which would adversely affect pitch provision may be proposed, then adequate replacement (equivalent or improved) should be secured in line with government policy guidance for the protection of playing field land. However, given the land restrictions in the city, the opportunities available to secure replacement playing pitch provision are limited.

The pitches within the city vary in quality, ranging from some which are at an unsatisfactory standard, to examples of good and great pitches in places. We will continue to assess and look for opportunities, in partnership with the NGBs; to improve those that fall below an acceptable parks provision standard. In some areas investment into improved maintenance and drainage programmes would increase the carrying capacity of natural turf pitches accommodating more use which may help reduce overuse, meet any further demand and support club development.

To ensure that Oxford continues to increase participation in sport, recreation and physical activity, it is important that the action plan is implemented and with local priorities being around Climate Change and Active Travel, a <u>Healthy Place Shaping</u> approach should be considered throughout implementation.

It is equally important that the strategy is reviewed on an annual basis and refreshed every five years and as part of the annual review the Active Places Power, Playing Pitch Calculator will be utilised to monitor current and future demand.

#### 1. Introduction

# 1.1 Why the strategy was developed

This strategy has been developed to assess current and future demand for playing pitches in Oxford city and to provide a robust framework for resource prioritisation and informed planning decisions.

There were a number of drivers behind this Playing Pitch Strategy being developed, these being:

The desire to:

- Maintain Oxford's position as one of the top performing local authorities in terms of participation in sport and physical activity as measured by Sport England's Active Lives Survey.
- Ensure that the benefits of providing sport and active recreation are recognised and where possible maximised to support the wider aims and objectives of the Council and partners (e.g. improving health and wellbeing, getting the inactive active, enabling inclusive and diverse use.)
- Enhance the strategic approach taken by the Council and partners to playing pitches and other outdoor sports facility provision; focussing on areas of greatest sporting need within the city, including areas of deprivation such as Rose Hill, the Leys and Barton.

- Highlight opportunities for the enhancement of existing sites that would both maintain and improve participation rates whilst embracing innovation.
- To tackle health inequalities and the obesity crisis, supporting a healthy place shaping approach.
- The value of bringing communities together through inclusive and diverse opportunities.

The need to:

- Provide robust and up-to-date evidence on the provision of playing pitches and outdoor sports facilities to protect and preserve existing sites, support the development and implementation of planning policy and inform assessments of individual planning applications.
- Ensure as a city we have sufficient facilities to meet the demand for matches and recreational play; for the current population as well as planning for expected population growth.
- Assess whether efficiency improvements can be made regarding the provision, management and maintenance of playing pitches and outdoor sports facilities, whilst maintaining and seeking to improve participation rates.
- Ensure that there is a greater joined-up approach to the provision of playing pitches and outdoor sports facilities within the city, bringing together key providers including Schools, Universities, Local Authorities and National Governing Bodies; especially around the agenda of community use.

At the time of development there was a Playing Pitch and Outdoor Sports Strategy in place for Oxford until 2026, but the decision was made after consultation with key partners and Sport England, to re-new rather than re-fresh that PPS to ensure there was a strategy in place for the city that remained robust against the changes in Sport England's PPS Guidelines and evolving priorities of the Council.

# 1.2 The study area

Oxford is a relatively small city with tight geographical boundaries. This offers some barriers around development and growth especially with an increasing and ageing population. There is also a high proportion of University and College land as well as some sites that are protected through Fields in Trust (FIT) or the Oxford Preservation Trust (OPT).

The total population of Oxford for 2018 according to the Office of National Statistics (ONS) Mid-2014 Population Estimates was estimated at 157,997 with a projected increase to 177,517 by 2032. Within this population there are areas of great affluence, but also pockets where significant health inequalities are experienced and this gap could potentially grow wider if demand in areas of regeneration remain unmet. There is also a very transient student population within this from both Oxford University and Oxford Brookes University, plus other local Colleges.

Recent Active Lives data suggests that for all of the main pitch sports there will be some latent demand in Oxford:

- Hockey 300 people,
- Rugby Union 550 people,
- Cricket 750 people
- Football 2,100 people.

The PPS mainly covers the following types of sports pitches and outdoor sports facilities:

- Natural turf pitches (NTPs) for Football, Rugby Union and Cricket.
- Artificial Grass Pitches (AGPs) for Hockey, Football and Rugby

To enable a full picture of natural turf playing pitch provision and needs to be identified, the strategy also picks up the requirements of some smaller pitch sports where they are known to be active within the city e.g. Lacrosse, Gaelic Football, Softball and most recently Quidditch which is a sport that is quickly establishing itself in the city. Tennis has also been included as there are a number of Local Authority sites within the study that also house community outdoor tennis courts so their inclusion paints a more accurate picture of site usage.

AGPs are included due to their now high level importance to various pitch sports for both match play and training activity, and given the recent development of these facilities in the city as well as planned developments coming through.

The chosen study area of Oxford city covers the city district but also includes the following sites and clubs which sit outside of the district boundaries but were highlighted as being involved in the supply and demand process of playing pitch provision and usage:

# 1.3 The approach to developing the strategy

The approach taken by the Steering Group and Project Team in developing this PPS followed Sport England's Playing Pitch Strategy Guidance to structure and direct the process, but also ensured where required that it was tailored to the specifics of the Oxford study area.

Developing the strategy centred on a collaborative approach; involving key partners at all stages through the Steering Group to ensure the strategy was based on a true reflection of the supply and demand in the city, had a realistic action plan owned by all partners and therefore was a strategy fit for purpose.

Our approach followed the key stages from Sport England's Guidelines:

Stage A: Prepare and tailor the approach (Step 1)

Stage B: Gather information and views on the supply of and demand for provision (Steps 2 & 3)

Stage C: Assess the supply and demand information and views (Steps 4, 5 & 6)

Stage D: Develop the strategy (Steps 7 & 8)

Stage E: Deliver the strategy and keep it robust and up to date (Steps 9 & 10)

Supply and demand data was collected in a number of ways:

- Pitch usage This was provided by the relevant NGBs, education partners and City Council Parks Team.
- Pitch quality This was collected through non-technical assessments carried out on all Council owned community pitches and a number of privately owned education pitches with all data cross checked by the relevant NGBs.
- Pitch satisfaction The city clubs (pitch sports only) were consulted around this through a Club Survey.

See Appendix 1 for the data collected as part of Stage B.

# 1.4 The vision for the strategy

The vision for this strategy which was agreed with the stakeholders in our steering group is:

"To support and encourage participation in sport and physical activity through a robust, fit for purpose framework that promotes accessible, affordable and sustainable playing pitch and outdoor spaces to meet both the current and future local needs."

The lifetime of this PPS will fall in line with that of the new Council Local Plan (2016-2036).

# 1.5. The key objectives of the strategy

The agreed objectives in terms of developing this strategy were:

- 1. To gather the best available supply and demand data on playing pitches and other outdoor sports facilities.
- 2. To assess the supply and demand data in line with available national guidance and identified good practice.
- 3. To ensure a good level of consultation with key parties throughout the development of the strategy.
- 4. To provide a robust evidence base, which can be used by a range of Council departments and other parties to help protect and improve the provision of playing pitches and other outdoor sports facilities.
- 5. To establish a clear prioritised list of actions, which will help to maintain and increase participation levels in sport and physical activity. We will also target those who are not participating as well as our diverse communities within the City and ensure the efficient use of resources.
- 6. To establish clear prioritised infrastructure requirements, including where new facilities are required and existing facilities should be enhanced. Helping to support healthy place shaping within the city and aligning with the Council's climate emergency agenda.
- 7. To identify and promote good practice regarding the provision, management and maintenance of playing pitches in the city.
- 8. To establish a process to ensure the regular review and update of the strategy and the information on which it is based.

These objectives support the Oxford City Council Corporate Plan outcome of Strong and Active Communities; helping to achieve the far reaching cross societal health, wellbeing and community benefits enabled by taking part in sport and physical activity.

#### 1.6 Managing the development of the strategy

In order to ensure a partnership approach to developing the strategy, a steering group was formed to oversee the management of the work. The group met at the key stages of the work to review progress, check and challenge data and shape the next steps and had representation from all key pitch sport NGB's, local Planning, Sport England and other key stakeholders such as the Universities and Playing Fields Association.

This group will continue to meet bi-annually to review progress made against the action plan and ensure the strategy remains fit for purpose.

#### Summary – NTPs

- According to the Active Places Power Audit there are a total of 122 operational natural turf football pitches within the city; 68 of which are in school/college/University grounds, and 54 are Local Authority owned.
- From these; 83 natural turf football pitches have been included within this study. The 39 missing sites are from independent schools/colleges that did not engage in this process.
- Out of the 83 natural turf pitches included in this study only 6 are not available for community use and of the other
   77 available for community use only 43 pitches are actually used.
- Currently the total community use on all of our community available natural turf football pitches is 161 match
  equivalent sessions per week with 69 match equivalent sessions per week reported as spare capacity and around
  half of the stock being played to capacity or being over-played.
- There is some spare capacity for all age range pitch types; all of which decrease significantly when the unsecured community use sites are removed from the equation.
- The community site with the greatest amount of overplay is the Junior Football pitch at Cowley Marsh Park with 4 match equivalent sessions per week.
- The consultation results from the Club Surveys and GMA audits highlighted a key concern was the perceived poor quality of the pitches in particular at Quarry Recreation Ground, Blackbird Leys Park and flooding at Grandpont Recreation Ground.
- The 11v11 pitch at Northway Community Centre and the 7v7 at St Nicholas's Primary School, however had a Quality Rating of Poor.

#### Summary – AGP's

- There are 15 operational football AGP's in the city; all of which are available for community use.
- There is spare capacity of 14 match equivalent sessions at weekends available at the Blackbird Leys AGP (if it is retested and added to The FA 3G register) and the football AGP at The Oxford Academy also shows it may be able to accommodate some additional play of on average 2 match equivalent sessions per week, but this changes throughout the year.
- With the recent completion of 1 new football AGP at Barton Park and 2 new football AGPs at Oxford Sports Park there may also be some spare capacity across these sites once the local club usage has been implemented.

#### Summary – General Football

- There are 76 football clubs in the city, 16 of which actively engaged in this PPS process. These 16 clubs have 113 teams between them; 16 adult men's, 5 adult women's, 44 youth and 48 mini teams.
- The needs of the affiliated clubs who have not engaged in this process have hopefully still been reflected in this study through Officer insight and OFA feedback.
- Summertown Stars FC have mid-week evening training displaced to Kidlington and Gosford, due to not enough floodlit pitches being available to them and their high number of teams.
- Latent demand has been reported from Headington Youth FC and Summertown Stars FC. For Headington Youth FC this could be met through access to more NTPs and/or an AGP for training. For Summertown Stars FC this could be

met if more volunteer Coaches and Managers came forward and then mid-week training facilities were found for these teams.

- Team Generation Rates (TGR's) based on future population indicate that participation is anticipated to create an one additional senior men's, 14 youth boy's and 6 youth girl's teams. The Active Places Power Playing Pitch Calculator estimates demand of a further 4.5 adult, 7 junior and 5.74 mini match equivalent sessions per week for matches and a further 35 hours on an AGP per week for training by 2039.
- A number of Football Clubs in the city have indicated that they expect to grow in the near future including Donnington FC, Headington Youth FC. Hinksey Park FC, Horspath Youth FC, Oxford City FC, South Park Rangers FC and Summertown Stars FC.
- The <u>Active Places Power Playing Pitch Calculator</u> estimates demand for a further 4.5 natural turf adult pitches, 7 youth pitches and 5.74 mini soccer pitches. Plus a further one additional AGP by 2039. There are already development plans in place that meet these AGP requirements however at St Gregory the Great School and Cherwell School. With these two developments the city would then have one AGP more than the predicted demand, but with demand ever changing it would be recommended to monitor AGP provision on an annual basis to ensure demands are met.

# Scenarios

The methodology and steering group agreed to work through some key localised scenarios. These scenarios were once that were put forward by members of the steering group or from community insight.

# What impact would the addition of a football AGP at Cherwell School and St Gregory the Great School have on training facilities and NTP usage?

- The addition of these two new football AGPs would provide an extra 68 hours per week a minimum of 38 of which would be training slots. Whilst there is already spare capacity across the existing AGP stock (reportedly 328 peak hours per week) we are aware from some clubs that there is a lack of availability for training at certain times and in certain areas of the city so this spare capacity is not necessarily lining up with the on-going demand.
- A new football AGP at Cherwell School would meet some of this demand from local team Summertown Stars FC and a new football AGP at St Gregory the Great School would be well placed to meet some of this demand from local team Quarry Rovers FC.
- If these two new AGPs were used to capacity by moving existing football usage from natural turf pitches that would potentially remove up to the equivalent of 68 peak hours usage and a minimum of 38 training slots from our natural turf pitch stock.
- The specific impact of this is unknown at this time, but we know that the key clubs using the new AGPs will be Summertown Stars FC and Quarry Rovers FC who mainly play at Cutteslowe Park, Five Mile Drive and Quarry Recreation Ground which are sites that have no spare capacity and anecdotal reports of being overplayed.
- So the impact would be that with training and match play from these clubs and potentially other local informal usage moving to the new AGPs some natural turf football pitches that are currently being overplayed may drop to being at capacity and some pitches that are currently at capacity may have some spare capacity moving forwards. This would in turn have a positive impact on the quality of those pitches that are currently being overplayed.

# What would happen if community use at educational sites was removed – if those sites were no longer happy to support community use due to other pressures on schools/colleges?

- In this scenario there would not be any displaced play as there is spare capacity across natural turf pitches and AGP's that could cater for this; however that is dependent on timing requirements aligning.

#### What would happen in the event of the closure of an AGP?

- In this scenario there potentially would not be any displaced play as there is spare capacity across natural turf pitches and other AGP's that could cater for the average usage on an AGP. (This is on the proviso of the Oxford Sports Park being available for the suggested amount of Community Use.)

#### Recommendations

- Support the football AGP developments at Cherwell School by providing advice and signposting any funding opportunities.
- Support the improvement of the existing AGP facilities at St Gregory the Great school including feasibility around the option of a full sized football 3G.

- Explore how we can improve natural turf pitch quality across some sites Blackbird Leys Park, Cowley Marsh, Cutteslowe Park, Court Place Farm, Five Mile Drive, Grandpont Recreation Ground and Quarry Recreation Ground.
- Make better use of existing natural turf pitches through improved maintenance and more over-marking.
- Maximise use of current AGP provision where there is spare capacity.
- Explore sites where additional pitches could be marked out and where green space could be brought to pitch playing quality to create new pitches where feasible.
- Explore the relocation of all pitches at Sandy Lane with proposals to relocate two adult 11v11 pitches to Herschel Crescent, one new 7v7 at Blackbird Leys Park or within the locality and pitch improvement works/hybrid pitch replacement of adult 11v11 pitch at Blackbird Leys Park.

# 3.2 Rugby pitches

#### Summary – NTPs

- According to the Active Places Power Audit there are a total of 52 operational natural turf rugby pitches within the city; all of which are owned by a school/college/University.
- For the purposes of this study we have included the pitches at Horspath Athletics Ground and Oxford Rugby Club which are on the borders of neighbouring District Authorities.
- From all of these; 34 natural turf rugby pitches have been included within this study. The missing sites are from independent schools/colleges that did not engage in this process and where there is currently no community use.
- Out of the 34 natural turf pitches included in this study only 2 sites and 13 pitches are not available for community use at Cheney School and Oxford Rugby Club. Of the other 21 available for community use 4 sites and 13 pitches are used; the 8 unused pitches are at St Edwards School who have however indicated they are interested in opening up for community use.
- Most rugby play occurs at club sites and it is only in unusual circumstances that play takes place at community sites.
- There is some spare capacity across both senior and junior/mini pitches but this is all unsecured.
- The sites with the greatest amount of overplay are The Oxford Academy and Horspath Athletics Ground with 6.5 match equivalent sessions per week each.
- All community use pitches being used were rated on a scale of quality see appendix 1.2 for details.
- It is important to recognise that if community use were no longer available at The Oxford Academy then local club Littlemore RFC would no longer have a pitch or training facility.

#### Summary - AGP

- The new rugby AGP at Horspath Athletics Ground currently shows 14 peak hours per week of spare capacity.
- The pitch under the dome at The Oxford Academy is no longer World Rugby compliant due to a lapse in the certification. It is believed this has not been renewed because the surface has deteriorated and there has been very little rugby use.

#### Summary – General Rugby

- There are 5 rugby clubs within the city, all of which actively engaged in this PPS process as well as Gosford All Blacks who are based just outside of the city boundary and so formed part of the study area. These 6 clubs have 55 teams between them; 16 senior men's, 4 senior women's, 13 junior teams and 22 mini age groups.
- All rugby teams are club based which is typical for the sport and how the RFU see club development moving forwards. Other suitable community pitches available at other sites are therefore not typically utilised by the clubs.
- Sports lighting has been raised as of particular interest by Littlemore RFC at The Oxford Academy to support their 2 current senior teams and ambition for Junior teams, however it may also be relevant for Oxford RFC who heavily overuse their only lit pitch for training in the winter period, but have 2 other designated senior pitches that could share the use.
- Team Generation Rates (TGR's) based on future population indicate that participation is anticipated to create an additional 1 senior men's, 4 junior boy's and 1 junior girl's teams. The Active Places Power Playing Pitch Calculator estimates demand of a further 4.5 match equivalent sessions per week for matches and 4.85 match equivalent sessions per week on a sports lit natural turf pitch for training by 2039.
- All of the Rugby Clubs in the city have indicated that they expect to grow in the near future as well as Gosford All Blacks RFC which has been included in the study area.
- The Active Places Power Playing Pitch Calculator estimates demand for a further 4.5 natural turf pitches by 2039.

#### Scenarios

# What impact would increasing maintenance/improving drainage at the club based pitches have on their quality ratings and therefore carrying capacities? (Oxford Harlequins RFC - Horspath Athletics Ground, Oxford RFC and Littlemore RFC – The Oxford Academy)

- All of the existing natural turf pitches at these club based sites are being overplayed and some quite heavily overplayed.
- None of the above listed pitches currently score above adequate or standard on the drainage and maintenance assessment (M1/D1) which limits those pitches to a maximum of 2 match equivalent sessions per week and those that score below this; fewer sessions per week.
- If this pitch quality scoring could be increased through an improved maintenance and drainage programme at the site then this would increase the carrying capacity of the pitches allowing them to cope better with the existing levels of play and for the senior pitches at Horspath Athletics Ground it would support more training/matches per week.
- A combined programme provides the greatest impact in terms of increasing carrying capacity across these pitches (an additional 31 match equivalent sessions per week), but not to the extent of accommodating all of the current usage (55 match equivalent sessions per week). Only the 2 senior pitches at Horspath Athletics Ground would be brought to being at or under capacity with any of these options\*. All other pitches would remain overplayed, but arguably in a better condition to handle the current level of play.
- Since this scenario was tested a third senior pitch has now been added to the site where a cricket pitch was removed. This will now allow the two senior pitches to be played to capacity only and provide greater options for increasing carrying capacity at the site if maintenance and/or drainage improvements are implemented across the natural turf pitches.

#### Recommendations

- Support the RFU and local Clubs to improve pitch quality through external funding opportunities, and to increase carrying capacities through improved pitch maintenance via linking to RFU PCP (Pitch Contractor Partnership).
- Increase changing provision and social space at Horspath Athletics Ground and Oxford RFC to aid game development.
- The RFU and clubs look to secure long term lease on St Peter's Field for Oxford RFC.
- Investigate feasibility of World Rugby compliance at all new AGP sites.
- Explore sports lighting for senior pitches at The Oxford Academy and Oxford RFC.
- Support Littlemore RFC to secure long term lease of pitches at The Oxford Academy site.

# 3.3 Hockey pitches (AGP's)

#### Summary

- According to the Active Places Power Audit there are a total of 13 operational Hockey AGP's in the city; all but 3 of which are owned by educational bodies. The other 3 are owned by the Local Authority; 2 located at Banbury Road North Sports Ground, but are managed by the Sports Club there; Oxford Hawks HC and 1 located at East Oxford Astro.
- From these; 9 of the pitches have been included in this study, 8 of which are full sized, 3 are sand-filled and 6 are sand-dressed. All have sports lighting however the pitch at Headington Girls School is currently restricted to 8pm. The missing 4 sites are all educational sites that did not engage in this process, but currently offer no community use.
- There are only 3 pitches within the study that do not currently offer formal community use; 2 at St Edwards School and 1 at St Gregory the Great School. However St Edwards School are used sporadically by Oxford Hawks HC as an overflow site and the school have highlighted that they are interested in introducing more formal community use moving forwards. It is currently unclear what this would look like in terms of days/times and whether that would meet any of the hockey club's needs.
- The AGP at St Gregory the Great has not been used for hockey for some time and has a quality rating of 'poor'.
   Recently an agreement has been reached between the relevant parties to replace the surface with a football AGP subject to available funding. England Hockey is keen to see some displacement of football from Headington Girls School on the development of this site to support much needed training time for Oxford HC.
- The AGP at East Oxford Astro is a small 36 x 21 AGP that offers informal community use and booked through pitchooking.com; there is currently no club use at this site.
- The 8 full sized operational pitches provide 98 peak community use hours during the week, 38 match slots on a Saturday and 37 match slots on a Sunday.
- Both pitches at North Oxford Sports Club are being overplayed as the pitches are home for Oxford Hawks Hockey Club, Adastral Hockey Club and also provide some football use.
- The Oxford Academy shows spare capacity of 10 hours during the week and 8 match slots each on a Saturday and a Sunday – however the pitch can be booked informally for other community use through the school so the hockey clubs do not have exclusive use. There may also be some issues accessing ancillary provision that mean this is not a suitable site for training or matches.
- All other pitches are being played to capacity.
- According to the Active Places Power Audit there are also 9 natural turf hockey pitches in the city all of which are owned by educational bodies, none of which currently offer community use and are not recognised by England Hockey for competitive use – these have therefore not been included within this study.
- There are 4 Hockey Clubs in the city all of which engaged in this PPS process. These 4 clubs have 43 adult teams between them; 21 senior men's, 19 senior women's and 2 senior mixed teams plus a total of 584 junior players. It

should be noted that Oxford Brookes HC and Oxford HC have recently merged and Adastral HC only have 1 mixed team that plays friendly matches.

- Oxford Hockey Club have reported unmet demand for ladies social play and Back 2 Hockey sessions.
- Team Generation Rates (TGR's) based on future population indicate that participation is anticipated to create an additional 1 senior men's team. The Active Places Power Playing Pitch Calculator estimates demand of a further 1.85 adult and 0.5 junior match equivalent sessions per week for matches and a further 5.5 hours on a sand based AGP per week for training by 2039.
- The Active Places Power Playing Pitch Calculator estimates demand for a further 0.46 sand based AGP by 2039.

#### Scenarios

# Education – What would happen if community use at educational sites was removed – if those sites were no longer happy to support community use due to other pressures on schools/colleges?

- With no spare capacity across the non-educational sites for hockey, all of the play currently at the educational sites would be displaced. This equates to 40 peak weekday hours and 27 weekend match slots for hockey.
- In this scenario it would be critical to look at maximising the non-educational sites through better timetabling, over-marking pitches and exploring additional pitches in a bid to re-home the displaced play.
- It is worth noting that the sites with the greatest amount of community use currently are Brookes Sport Headington and The Oxford Academy and both of these have secured community use agreements in place making this scenario unlikely.
- In summary there is a significant amount of hockey use that is reliant on educational sites and removal of this would displace a large amount of play.

If Oxford Hockey Club were to gain an additional dedicated AGP what impact would that have on the existing sites they are currently using and what opportunities would that create for other clubs in the city and for hockey use generally?

- The club would no longer require sporadic use of The Oxford Academy, but this usage is relatively low (10 hours per week maximum) and it is not expected that the academy would have trouble filling those slots.
- The club's usage at Headington School would also reduce (in the short term) as that would become their 3rd pitch mainly used by the lower teams. However the club could grow to fill the capacity at the school again through emerging teams and new informal use.
- Providing the club with a consolidated base creates a more sustainable model for the club's future and growth.
- There may be knock on opportunities around development of a clubhouse and the club moving to manage the site, becoming as asset owner which would further support the club's sustainability.
- The impact on Oxford Hawks Hockey Club is expected to be minimal if any at all.
- In summary the impact of this development is predicted as being mainly positive for hockey in the city and is something which the club would be encouraged to explore if funding opportunities were also made available from England Hockey, the University or other sources.

#### Recommendations

- Consolidating hockey into key sites to ultimately increase overall provision.
- Protecting the current active hockey sites.
- Exploring possibility of implementing CUA's at all relevant existing sites (Headington Girls School, St Edwards School and Oxford Brookes Headington.)
- Maximising capacity at Headington Girls School (exploring extending floodlight hours and gaining Tuesday evening usage from football.)
- Working with the sports clubs to explore how we can improve ancillary provision at Banbury Road North and improve access at The Oxford Academy.
- Exploring an informal offer at East Oxford Astro with Oxford HC.
- Explore the opportunity that a new football AGP could release capacity that could help hockey clubs meet some of their training demand.

#### 3.4 Cricket pitches

#### Summary

- According to the Active Places Power Audit there are a total of 32 operational cricket pitches in the city; all but 3 of which are owned by educational bodies. The other 3 at Botley Park, Cowley Marsh Park and Cutteslowe Park are owned by the Local Authority. Since this Audit there are now an additional 2 pitches at Oxford Sports Park.
- All of these pitches have been included within this study plus a number of key sites for cricket that sit outside of the study area such as Stratfield Brake. From these; 26 of the pitches are college sites or sites that sit outside of the city boundary which we have less information around and 15 are community or school pitches within the city.
- Out of the 15 community or school pitches 10 are natural turf wickets and 5 are artificial grass wickets, 1 site (Cheney School) is not available for community use and out of the 14 pitches available for community use only 4 are not currently used Oxford Sports Park, St Edwards School (although this is used sporadically) and The John Henry Newman Academy.
- There is spare capacity of 60 match equivalent sessions per season across the natural turf wickets and this includes the new Oxford Sports Park site. This drops to 20 if the unsecured sites are removed.
- The majority of cricket usage is at unsecured college sites such as Oxford University Press. Although there is a risk that community use could be stopped at these sites, the colleges are all independent of each other so it is unlikely that this would happen en masse.
- On the artificial grass wickets spare capacity is showing across Botley Park, Grandpont Recreation Ground and Quarry Recreation Ground, but these are free, publicly accessible wickets that are non-bookable. There are 18 match equivalent sessions per season showing as spare capacity at Cutteslowe Park and 120 at Oxford Sports Park which is soon to be available for booking. That totals 138 match equivalent sessions per season.
- The natural turf wicket at Horspath Sports Ground was recently removed and replaced with a senior natural turf rugby pitch by agreement of the ECB, OCB, Oxford Harlequins RFC and the RFU as the cricket wicket did not meet ECB standards and was not actively being used for cricket. The rugby club have also secured funding and planning permission to install sports lighting on this pitch.
- Flooding and water logged pitches is reportedly an issue for clubs at Cowley Marsh, Cutteslowe Park, and Grandpont Recreation Ground.
- There are 3 cricket clubs based within the city boundary all of which engaged in this process, but another 4 clubs highlighted as key to the study area that were also included in this PPS; Horspath, Holton & Wheatley, Cumnor and Wytham CC. These 7 clubs have a total of 49 teams; 23 open age men's, 3 open age women's, 22 junior boy's and 1 junior girl's teams.
- Wolvercote Cricket Club who play at Cutteslowe Park have one senior team displaced to Brill CC and Aylesbury Vale CC as not enough space at Cutteslowe during peak times.
- Oxford Cricket Club have indicated they require more capacity to cater for all their youth fixtures.
- Team Generation Rates (TGR's) based on future population indicate that participation is anticipated to create an additional 0.5 senior men's, team. The Active Places Power Playing Pitch Calculator estimates demand of a further 33 open age and junior match equivalent sessions per season by 2039.

- Cumnor, Oxenford and Oxford Cricket Clubs have all predicted growth in their clubs; Cumnor CC 1 Women's Team (open age), Oxenford CC 1 Women's Team and 3 Junior Teams and Oxford CC a minimum of 1 Junior Team.

#### The Active Places Power Playing Pitch Calculator estimates demand for a further 0.73 grass pitches by 2039.

#### Scenarios

# Education – What would happen if community use at educational sites was removed – if those sites were no longer happy to support community use due to other pressures on schools/colleges?

- A minimal amount of the displaced cricket play could be picked up by spare capacity at non-educational sites in the city leaving 201 match equivalent sessions per season which could not be picked by non-educational sites.
- In this scenario it would be critical to look at maximising the non-educational sites through better timetabling, over-marking pitches and exploring additional pitches in a bid to re-home the displaced play.
- In summary there is a significant amount of hockey use that is reliant on educational sites and removal of this would displace a large amount of play.

# What would the impact be of opening up a school/college site for community use on the current displaced match play?

- The displaced play is due to the quality of the affordable pitches available for match play and the cost of the higher quality pitches available for match play and not because there is no provision entirely (the data we have been able to collect indicates that there is actually already spare capacity of 60 match equivalent sessions per season). The average length of a cricket match also means that only 1-2 teams can play a match per day per pitch in the peak period so volume of play is restricted.
- Opening up further community use at educational sites would theoretically be able to accommodate the displaced play, but only if the sites were able to agree for the pitches to stay open beyond the school term.

#### Recommendations

- Explore opening/increasing access to Magdalen College School and St Edwards School
- As Open Cricket Teams (adult mixed) begin to increase in the city ensure there is access to multiple changing facilities at relevant sites on a match day.
- Explore the provision of square maintenance equipment for Oxford Sports Park.

#### **3.5 Other Sports Pitches**

# Summary

Tennis

- There are 4 city-based clubs Norham Gardens, North Oxford, Oxford City and Oxford Sports Tennis Club. Norham Gardens Tennis Club use courts at Alexandra Park and North Oxford Tennis Club share their ground with Oxford Hawks Hockey Club.
- As well as the club courts the city has 35 community courts across 6 community park sites which are currently operated by Together Active:

- Alexandra Park 6 courts + 9 grass courts
- Botley Park 2 courts
- Bury Knowle Park 4 courts
- Cutteslowe Park 5 courts
- Florence Park 5 courts plus sports lighting
- Hinksey Park 4 courts
- Weather can dramatically reduce the number of outdoor playing hours and where there are no sports lit courts; shorter days in the autumn and winter can further reduce this.
- Both of the above highlight a need for community indoor facilities and/or covered/floodlit outdoor courts in the city.
- Issues have been reported around the safety of some of the court surfaces at the community park sites in the winter months caused by the build-up of moss.

#### Netball

- There are 5 city-based clubs Abbey NC, Oxford Science Park NC, Oxford City NC, Oxford Royals NC and Summertown NC.
- The clubs mostly use school sites for training and matches or the Community Arena which has 6 courts and is a Central Venue for Netball in the County.
- There is a need for more indoor venues in the city to support Back to Netball and Walking Netball sessions to
  engage those less active/inactive.

#### Softball

- The Oxford Softball League involves 8-10 teams each year which mainly train and play at Horspath Athletics Ground – however there is some informal training pre-season in some of the city's parks such as Cutteslowe and Oatlands Park.
- From 2020 the Softball League will be moving across the road to the Oxford Sports Park.
- Both Oxford University and Oxford Brookes University also have teams most years.

# Lacrosse

- There are 3 city based clubs Oxford University, Oxford Brookes University and Oxford City Lacrosse Club.
- Oxford City Lacrosse Club has 1 mixed, 1 women's and 1 men's team plus a junior programme and have recently
  moved from Horspath Athletics Ground to The Oxford Academy as they required access to sports lit pitches for
  winter training sessions.

# **Gaelic Football**

- There is 1 club in the city Eire Og Oxford which are based at Horspath Athletics Ground and have 2 men's teams, 1 ladies team and 3 youth teams.
- Some winter training also takes place at Cherwell School.
- The club have indicated a need for increased access to sports lit pitches for winter training sessions as well as
  access to storage facilities.

#### **Rugby League**

- The main club in the city is the Oxford Cavaliers which has 2 junior teams that train at Oxford Rugby Club and 1 senior team that trains at Oxford Brookes University. There is a professional team from this club of the same name who are currently taking a break, but were based at OURFC Iffley Road and The Oxford Academy.
- The Oxford University has 1 men's team which train at Oxford University RFC and Oxford City FC.

# Quidditch

- This emerging sport has 2 clubs in the city Oxford University and Oxford Mammoths, both of which have 1 team currently.
- Both clubs currently train and play at University Parks; Oxford University term time only, but Oxford Mammoths train all year round.
- To grow the sport both clubs have highlighted the need for securing a home ground at a formal pitch site.

# **Other Sport Recommendations**

- Explore funding opportunities for court surface improvement works at Bury Knowle and Hinksey Park courts as a priority and Cutteslowe and Botley Park courts in the longer term.
- Continue to be open to opportunities for funding to increase provision of indoor tennis courts and floodlit/covered outdoor tennis courts.
- Seek to improve the maintenance regime to support on-going and potential increased use of the community tennis courts in the city.
- Explore the opportunities presented by a new tennis contract for management and operation of the tennis courts within the City.

- Continue to support those clubs who have moved their training/matches to Oxford Sports Park including the creation of a sports park steering group.
- Support positive relations to be maintained between the clubs sharing use of Horspath Athletics Ground.
- Work with key partners such as OXSRAD and other disability sports clubs to improve access and better promote the sport.
- Protect the existing quantity of provision for these sports.

### 4. Strategic Recommendations

Within Sport England's technical guidance it highlights the need to identify key strategic priorities. These are shown below.

#### 4.1 Strategic Aim - Protect

Recommendations that seek 'to protect playing pitch provision ir respective of ownership and the degree of community access and use, along with unused sites and land allocated as a playing field'.

- a) Protect the existing provision at all sites.
- b) Support local clubs in securing long term leases of pitches that help with sustainability of the club as well as ensuring the pitches remain as 'playing fields'. E.g. Oxford Rugby Club with St Peter's Field and Littlemore Rugby Club at The Oxford Academy.

#### 4.2 Strategic Aim - Enhance

Recommendations that 'look to make the best use of existing provision ensuring better quality, access and management'.

- a) Explore CUA's with educational sites that do or could play an important role in the development, growth or sustainability of key local clubs. E.g. Barton Park, Brookes Sport Headington, Headington Girls School, Magdalen College School and St Edward's School.
- b) Support sustainability and community accessibility of all Hub sites through site specific actions. This includes exploring opportunities to improve the quality of natural turf pitches at Blackbird Leys Park and Court Place Farm and developing/working with effective Stakeholder Groups at Horspath Athletics Ground and Oxford Sports Park.
- c) Introduce further measures within the planning and development stages of new sites and facilities that help to ensure wide community use. This includes a process whereby all new planning applications that include recommendation of a CUA are followed up to ensure the CUA is put into practice. Plus; exploring at initial stages of any further AGP developments whether it would be appropriate to also have them as World Rugby compliant. It should also reflect a Healthy Place Shaping approach with measures that support and encourage active travel to and from the site.

#### 4.3 Strategic Aim – Provide

Recommendations around the suggestion that 'new natural and/or artificial grass pitches are required to meet current and/or future demand'.

- *a)* Better utilise existing natural turf pitch stock where possible and required by looking at options for over-marking of pitches and exploring sites where additional pitches could be marked out
- *b)* Support the current development plans for a football AGP to replace the existing AGP at St Gregory the Great School and plans to provide new AGPs at the south site of The Cherwell School.
- c) Review the city's AGP provision annually to ensure it is meeting ongoing increasing needs.

#### 5. Action Plan

This site-by-site action plan list seeks to address key issues that have been identified through the Strategy. It provides recommendations based on current levels of usage, quality and future demand, as well as the potential of each site for enhancement.

# **Action Plan Columns:**

Site ID, Site, Sport, Management, Current Status and Recommended Actions all self-explanatory.

### Partners

The column indicating Partners first refers to the **lead organisation** identified to deliver the actions and the support partners to help deliver the actions.

# Site Hierarchy Tier

To allow for facility developments to be prioritised and programmed within a phased approach a tiered model for the improvement of playing pitch sites and associated facilities is recommended and so the following has been used.

Hub sites are of city wide importance where users are willing to travel to access the range and high quality of facilities offered and are likely to be multi-sport.

Key sites although these sites are more community focused, some are still likely to service a wider analysis area (or slightly wider). However, there may be more of a focus on a specific sport i.e. a dedicated site.

Local sites refer to those sites which are generally one and two pitch sites and may be Council owned hired to clubs for a season or are sites which have been leased on a long-term basis. However, they are also likely to be private club sites serving one particular sport.

Reserve sites could be used as overspill for neighbouring sites and/or for summer matches/competitions, training or informal play. They are most likely to be single-pitch sites with no ancillary facilities or school sites where there is no current demand for community use.

#### Timescales

The action plan has been created to be delivered over a sixteen year period. Some information within the Strategy and Action Plan will require updating as developments occur. The timescales relate to delivery times and are not priority based.

Timescales: (S) -Short (1-2 years); (M) - Medium (3-5 years); (L) - Long (6+ years).

#### Cost

The strategic actions have been ranked as low, medium or high based on cost. The brackets in which these sit are:

(L) -Low - less than £50k; (M) -Medium - £50k-£250k; (H) -High £250k and above. These are based on Sport England's estimated facility costs which can be found at <u>https://www.sportengland.org/media/13346/facility-costs-q2-18.pdf</u>

#### Aim

Each action seeks to meet at least one of the three aims of the Strategy:

- Enhance 'look to make the best use of existing provision ensuring better quality, access and management'
- Provide 'new natural and/or artificial grass pitches are required to meet current and/or future demand'
- Protect 'need to protect playing pitch provision irrespective of ownership and the degree of community
  access and use, along with unused sites and land allocated as a playing field'

### 6. How the Strategy will be delivered, monitored and updated.

It is important that there is good governance in place to ensure that these recommendations and action plan are implemented. The success of this strategy and the benefits that are gained are dependent upon regular engagement between all partners involved and the adoption of a strategic approach.

The role of the Steering Group will not end with the completion of the PPS document; instead each member of the group should take the lead to ensure the PPS is used and applied appropriately within their area of work and influence.

It is therefore proposed that the Steering Group will continue to meet every 6 months to update the action plan and the strategy will be refreshed every 5 years.

The six monthly reviews will address:

- How the delivery of the recommendations and action plan has progressed and any changes required to the priority afforded to each action (e.g. the priority of some may increase following the delivery of others)
- How the PPS has been applied and the lessons learnt
- Any changes to particularly important sites and/or clubs in the area (e.g. the most used or high quality sites for a particular sport) and other supply and demand information
- Any development of a specific sport or particular format of a sport
- Any new or emerging issues and opportunities.

The approach to the strategy refresh every 5 years will be in line with Sport England's Playing Pitch Strategy guidance.

The Council will also maintain regular meetings with the pitch sport NGBs and other relevant organisations to review general progress, developments, issues and opportunities.

To help ensure the PPS is delivered and is kept robust and up to date, the Steering Group will also refer to Sport England's methodology Stage E Checklist: Deliver the strategy and keep it robust and up to date:

### 2. Scenario workings

# 2.1. Education – What would happen if community use at educational sites was removed – if those sites were no longer happy to support community use due to other pressures on schools/colleges?

(May be unlikely that ALL these sites removed their community use, but difficult to pull out specific sites for this so easier to test against all.)

Spare capacity at all non-educational community use sites (available for community use and used + available for community use but not used):

- Adult Football = 3
- Junior Football 11v11 = 0
- Junior Football 9v9 = 5 (plus whatever spare capacity deemed to have at BBL Park)
- Junior Football 7v7 = 0
- Mini Soccer 5v5 = 0
- Senior Rugby Union = 0
- Mini Rugby Union = 0
- AGP Rubber (Football) = 326
- AGP Sand (Hockey) = 0
- Cricket Natural Turf = 15
- Cricket Artificial Grass = 138

All reported community use at education sites:

- Adult Football = 0
- Junior Football 11v11 = 0
- Junior Football 9v9 = 0
- Junior Football 7v7 = 0
- Mini Soccer 5v5 = 0

- Senior Rugby Union = 8
- Mini Rugby Union = 0 None of these pitch types at Community Use Education Sites
- AGP Rubber (Football) = 66
- AGP Sand (Hockey) = 40 weekday peak community hours and 27 match slots at the weekend
- Cricket Grass = 216 (estimated use refer to Pictures of Provision)
- Cricket Non-Turf = 0 None of these pitch types at Community Use Education Sites

### Comparison:

In this scenario there would be the following displaced play:

Natural Turf Cricket – 201 match equivalent sessions per season Senior Rugby - 8 match equivalent sessions per week Hockey – 40 weekday peak community hours and 27 match slots at the weekend

A minimal amount of the displaced cricket play could be picked up by spare capacity at non-educational sites in the city, but with no spare capacity across the non-educational sites for rugby or hockey all of the play currently at the educational sites for these sports would be displaced. This is only 8 match equivalent sessions for rugby, but 40 peak weekday hours and 27 weekend match slots for hockey. Plus 201 match equivalent sessions per season for cricket which could not be picked by non-educational sites.

In this scenario it would be critical to look at maximising the non-educational sites through better timetabling, over-marking pitches and exploring additional pitches in a bid to re-home the displaced play.

It is worth noting that the sites with the greatest amount of community use currently are Brookes Sport Headington and The Oxford Academy and both of these have secured community use agreements in place making this scenario unlikely.

In summary there is a significant amount of cricket, hockey and some rugby use that is reliant on educational sites and removal of this would displace a large amount of play.

**2.2.** AGP's – What would happen in the event of the closure of an AGP? (One rubber based AGP site (Court Place Farm) affecting Football.)

There are 15 community accessible Football AGP's across the city:

- Barton Park (1 x 3G 9v9)
  - Blackbird Leys LC (1 x 3G 7v7)
  - Court Place Farm (2 x 3G both 11v11)
  - Horspath Athletics Ground (1 x 3G 11v11 rugby)
  - Oxford Sports Park (2 x 3G 5v5 + 6 smaller)
  - The Oxford Academy (1 x 3G 11v11 and 1 x 3G 7v7/dome)

All of these sites have secured use and provide a current carrying capacity of 510 peak hours/week for the city. There are currently 169 of these peak hours reported as being used and from the 341 hours difference 328 of those peak hours per week are deemed as spare capacity. This spare capacity is across Barton Park (26hours/week), Blackbird Leys LC (14hours/week), Horspath Athletics Ground (14hours/week), Oxford Sports Park (272hours/week) and The Oxford Academy (2hours/week). There is not any spare capacity reported at Court Place Farm.

- If both AGP's at Court Place Farm were to close this would remove and displace 68 peak hours of play. However with 328 peak hours spare capacity across other sites this should be able to be rehomed.
- If the AGP's at Oxford Sports Park are removed from this scenario as they are smaller sized and not on the FA's register then this would change the statistics to: 8 secured community accessible 3G's giving a carrying capacity of 254 peak hours/week. With 185 of those peak hours reported as being used, out of the 85 hours remaining 56 peak hours/week are deemed as spare capacity. This spare capacity is broken up as 26 hours at Barton Park, 14 hours at Blackbird Leys LC, 14 hours at Horspath Athletics Ground and 2 hours at The Oxford Academy. There is not any spare capacity reported at Court Place Farm. In this instance most of the displaced play would be able to be accommodated but 12 peak hours/week would need to be found from other sites.

# 2.3 Cricket – What would the impact be of opening up a school/college site for community use on the current displaced match play?

We have chosen to use St Edwards School within this scenario test as the school has 6 high quality natural turf cricket pitches available at their site and they have already highlighted that they would be interested in providing more community use. (They already accommodate some usage for Wolvercote Cricket Club.)

Currently the only displaced cricket match play in the city is at Wolvercote Cricket Club who play most of their home matches at Cutteslowe Park (reportedly 47 matches there last season), but one of their men's teams (3<sup>rd</sup> team) has been playing at Brill Cricket Club in Buckinghamshire. We approximate this to be 13 matches per season based on the following:

- 9 x Saturday matches per season x 3 teams
- 9 x Sunday matches per season x 2 teams
- 6 x mid-week matches per season x 1 team
- 3 x additional friendly matches per season x 3 teams

= 60 match equivalent sessions per season

However our belief is that this displaced play is due to the quality of the affordable pitches available for match play and the cost of the higher quality pitches available for match play – and not because there is no provision entirely (the data we have been able to collect indicates that there is actually already spare capacity of 60 match equivalent sessions per season). The average length of a cricket match also means that only 1-2 teams can play a match per day per pitch in the peak period so volume of play is restricted.

The 6 natural turf cricket pitches at St Edwards School would provide 30 match equivalent sessions per season. With the current use by Wolvercote Cricket Club we believe there to be spare capacity of 15 match equivalent sessions per season.

Wolvercote Cricket Club usage at St Edwards School:

- U15's 6 home games per season
- Adults mid-week T20s 9 fixtures per season
- Youth training Tuesday evening 15 sessions per season (Only nets used)
- Adult training Thursday evening 15 sessions per season (Only nets used)

The quality of the pitches available at St Edwards School would certainly provide a high quality pitch for this displaced match play and at a site that is in close proximity to the club's Home Ground of Cutteslowe Park. The club currently do not pay for their use of the school and this arrangement is reviewed annually.

We believe that discussions around the school helping to accommodate extra match play for Wolvercote CC have taken place with the issue being that the school Groundsmen are keen to put the pitches to bed for the season when the school term finishes at the end of July. This issue is likely to be the same across all independent school and college sites. (However the nets have been made available to the club through to the 15<sup>th</sup> August.)

In summary opening up further Community Use at St Edwards School would theoretically be able to accommodate the displaced play, but only if the site were able to agree for the pitches to stay open beyond the school term. With a relationship already built they may be open to this discussion however it may also have an effect on the current pricing agreement offered. Another option is to move the displaced play to a site where there is spare capacity in the city such as Oxford Sports Park where affordability and quality should not be an issue, but if Oxford Cricket Club were to move there which is under discussion then all availability would be taken.

# 2.4 Football - What impact would the addition of a 3G pitch at Cherwell School and St Gregory the Great School have on training facilities and grass pitch usage?

### Impact on training facilities:

Currently there are 15 community accessible Football AGP's across the city of various sizes including 4 full-sized and 5 that are on the FA 3G Register. These provide a carrying capacity of 510 peak hours per week. The addition of these two new 3G pitches would provide an extra 68 hours per week.

Whilst there is already spare capacity across the existing 3G stock (reportedly 328 peak hours per week) we are aware from some clubs that there is a lack of availability for training at certain times and in certain areas of the city so this spare capacity is not necessarily lining up with the on-going demand.

A new 3G at Cherwell School would be well placed to meet this demand from local team Summertown Stars FC and a new 3G at St Gregory the Great School would be well placed to meet this demand from local team Quarry Rovers FC.

The Active Places Power Pitch Calculator also predicts a spike in the demand for training sessions of a further 34.96 peak hours per week and suggests the city will require another 1 (0.92) 3G Artificial Grass Pitch to meet this future demand. The addition of these 2 3G pitches will therefore meet this requirement and give us an over-supply to then cater for higher demand for certain playing times.

### Impact on natural turf pitch usage:

Currently the total community use on all of our community available grass football pitches is 161 match equivalent sessions per week with 69 match equivalent sessions per week reported as spare capacity and around half of the stock being played to capacity or being over-played.

If these two new 3G's were used to capacity by moving existing football usage from grass pitches that would potentially remove the equivalent of 68 peak hours usage from our grass pitch stock.

The specific impact of this is unknown at this time, but we know that the key clubs using the new 3G pitches will be Summertown Stars FC and Quarry Rovers FC who mainly play at Cutteslowe Park, Five Mile Drive and Quarry Recreation Ground which are sites that have no spare capacity and anecdotal reports of being overplayed.

So the impact would be that with training and match play from these clubs and potentially other local informal

usage moving to the new 3G's some grass football pitches that are currently being overplayed may drop to being at capacity and some pitches that are currently at capacity may have some spare capacity moving forwards. This would in turn have a positive impact on the quality of those pitches that are currently being overplayed.

# 2.5 Rugby: - What impact would increasing maintenance/improving drainage at the club based pitches have on their quality ratings and therefore carrying capacities?

This scenario relates to the following clubs, sites and pitches: Oxford Harlequins RFC - Horspath Athletics Ground – 4 x mini natural turf pitches and 2 x senior natural turf pitches (There is also a brand new AGP at this site that is not included in this scenario). Oxford RFC – 8 x mini natural turf pitches and 3 x senior natural turf pitches. Littlemore RFC – The Oxford Academy – 1 x senior natural turf pitch.

All of the natural turf pitches at these club based sites are being overplayed and some quite heavily overplayed. We have been able to calculate this by comparing the known current community use with the current recommended carrying capacity for each pitch.

The carrying capacity for each pitch has been ascertained using the RFU's guide on the number of match equivalent sessions that natural turf pitches should be able to sustain without adversely affecting their current quality. This is calculated using a matrix of the non-technical pitch assessment results of the drainage system and maintenance programme afforded to that site:

None of the above listed pitches currently score above adequate or standard on the drainage and maintenance assessment (M1/D1) which limits those pitches to a maximum of 2 match equivalent sessions per week – and those that score below this; fewer sessions per week. (A 2 hour training sessions would also equate to 1 match equivalent session).

If this pitch quality scoring could be increased through an improved maintenance and drainage programme at the site then this would increase the carrying capacity of the pitches allowing them to cope better with the existing levels of play and for the senior pitches at Horspath Athletics Ground it would support more training/matches per week.

The RFU suggest that an increase of £5-6k annual spend on pitch maintenance per pitch would move a pitch up by 1 maintenance quality rating score e.g. M0 to M1. They also suggest that a one-off investment of £60-80k would install an improved drainage system for one senior pitch and would move the pitch up to the top drainage quality rating of D3. The below tables show the current quality ratings given to each pitch and the resulting carrying capacities compared with the potential carrying capacity for each pitch if the relevant quality ratings were to increase by 1 score with an increased/improved maintenance programme, the top drainage system or a combination of them both:

A combined programme clearly provides the greatest impact in terms of increasing carrying capacity across these pitches (an additional 31 match equivalent sessions per week), but not to the extent of accommodating all of the current usage (55 match equivalent sessions per week). Only the 2 senior pitches at Horspath Athletics Ground would be brought to being at or under capacity with any of these options<sup>\*</sup>. All other pitches would remain overplayed, but arguably in a better condition to handle the current level of play.

\*To gain the additional 1 match equivalent session per week required to meet current usage across the 2 senior pitches at Horspath Athletics Ground, any of the options could be chosen. To increase the carrying capacity to be able to accommodate additional play across these two pitches then either the drainage improvement only or combined programme of improving both the drainage and maintenance would achieve this with 2-3 match equivalent sessions per week being made available.

All options obviously require investment and therefore funding would need to be sought not only for initial development/improvement, but also for on-going maintenance.

Update: There is now a third natural turf pitch at Horspath Athletics Ground where a cricket pitch was previously located. Whilst we are currently unable to determine the quality rating of this additional pitch we are presuming it is the same as the other natural turf pitches at the site which is M1/D0 which gives it a carrying capacity of 1.5 match equivalent sessions/week.

With this additional pitch marked out and used as a senior pitch it will mean the site is able to provide a total of 4.5 match equivalent sessions per week through its senior natural turf pitches which will accommodate the current senior usage of natural turf pitches at the site (4 match equivalent sessions/week) with a spare 0.5 match equivalent sessions per week available. This is without any programme of improved drainage or maintenance. With improvements to the drainage or maintenance programmes across all 3 senior natural turf pitches there would be spare capacity of between 2 match equivalent sessions (if maintenance improvements only), 5 match equivalent sessions (if drainage improvements only) and

6.5 match equivalent sessions (if both maintenance and drainage were improved).

Adding sports lighting where there is currently none available would also increase availability at those sites by 2 evening training sessions per week per lit pitch between September and April annually. This would need to be supported by such an increased/improved maintenance programme.

# Update: The club have recently gained both funding and planning permission to add sports lighting at this third natural turf senior pitch; adding 2 evening training sessions per week.

Sports lighting has been raised as being of particular interest by Littlemore RFC at The Oxford Academy to support their 2 current senior teams and ambition for Junior teams, however it may also be relevant for Oxford RFC who heavily overuse their only lit pitch for training in the winter period, but have 2 other designated senior pitches that could share the use.

# 2.6 Hockey: - If Oxford Hockey Club were to gain an additional dedicated AGP what impact would that have on the existing sites they are currently using and what opportunities would that create for other clubs in the city and for hockey use generally?

England Hockey's priority for the Oxford area is to move towards consolidating the city based clubs to as few as sites as possible to provide a more stable and sustainable club base.

Oxford Hockey Club currently spread their training and match play across Brookes Sport Headington and Headington Girls School with some low level sporadic use of The Oxford Academy.

The club have recently merged with Oxford Brookes Hockey Club and as a result have plans to develop a new women's and a new men's team.

The pitch at Brookes Sport Headington is being played to capacity and the club have near exclusive use of the pitch at

Headington Girls School. There is some spare capacity at The Oxford Academy however issues with the pitches location and access to ancillary provision have been highlighted by the club as making it less than an ideal pitch for them.

The club have suggested a potential development at a nearby site for a new 3G would provide them with exclusive use in peak hours and a more consolidated base with their current main site at nearby Brookes Sport Headington.

The predicted impact of this development would be:

- The club would no longer require sporadic use of The Oxford Academy, but this usage is relatively low (10 hours per week maximum) and it is not expected that the academy would have trouble filling those slots.
- The club's usage at Headington School would also reduce (in the short term) as that would become their 3<sup>rd</sup> pitch mainly used by the lower teams. However the club could grow to fill the capacity at the school again through emerging teams and new informal use.
- Providing the club with a consolidated base creates a more sustainable model for the club's future and growth.
- There may be knock on opportunities around development of a clubhouse and the club moving to manage the site, becoming as asset owner which would further support the club's sustainability.
- The impact on Oxford Hawks Hockey Club is expected to be minimal if any at all.

In summary the impact of this development is predicted as being mainly positive for hockey in the city and is something which the club would be encouraged to explore if funding opportunities were also made available from England Hockey, the University or other sources.

### 12. NGB Strategic Plans

### 12.1 The Football Association

The National Football Facilities Strategy 2018 -2028

The FA, in conjunction with the Football Foundation and funding partners; The Premier League and Government have developed a ten-year investment plan in facilities for grass roots football. The facilities strategy aims to ensure that by 2028:

- Every FA-affiliated club has access to a 3G artificial pitch for training and potentially matches.
- Accelerated improvements are made to the key grass pitch sites across England to reduce fixture cancellations. The FA states that approximately 1 in 6 grass roots matches are called off nationally due to poor pitch quality.

The strategy sets out to provide:



## Survive. Revive. Thrive. The FA Grassroots Football Strategy 2020 - 2024

The Purpose of the Grassroots Football Strategy is to 'Harness the Power of Football to Unite Communities and Improve the Health of the Nation.'

The intention is to use the huge reach of the game and translate this reach into bringing people from every background together to enjoy a lifelong relationship with football and with each other, to the benefit of our society.

The strategy is centres on those who play the game. We want to make the experience as fun, safe and inclusive as possible. In the male game, we want to respond to the needs of players by providing more flexibility and better access to football opportunities to encourage their retention in the game. In the female game, the push is to ensure girls have the same access as boys to football opportunities in schools and clubs, and that women have choice too.

The FA are committed to ensuring the pathways into and through the male and female games include disability provision, with bespoke participation opportunities as needed.

To deliver the goals for male and female football, there must be a vibrant, best-in-class club network around the country. The FA will work to encourage as many clubs as possible to achieve FA-Accredited status, assuring quality in everything they offer, including ever-safer and stronger player pathways. This will be coupled with a commitment to improve the quality of thousands of pitches up and down the country, with a particular focus on grass pitches.

The FA will focus on the grassroots workforce, providing the support and encouragement needed to serve the game in local communities. All the above will be enabled by a suite of cutting-edge digital products and services to make running the game as easy as possible – and critically, a safe, positive, and inclusive environment that is free from discrimination and tackles inequality, particularly in disadvantaged communities.

# 12.2 England Rugby

England Rugby Strategy – A Successful and thriving game across England.

Through our strategy, we aim to enrich lives, introduce more people to rugby union and develop the sport for future generations, creating a successful and thriving game across the country. We aim to achieve this by strengthening and uniting rugby union in England and producing consistently winning England teams. Through this process, eight key strategic priorities were identified these are –

- Enabling Positive and enjoyable player experiences
- Creating the best possible high performance system
- Enhancing player welfare
- Supporting clubs to sustain and grow themselves.
- Driving rugby union to reflect the diversity of society
- Building a deep understanding of players, volunteers and fans to shape the future of the game
- Connect and grow the rugby community
- Ensure a sustainable and efficient business model delivered by an inspired workforce.

Working to achieve the above all the RFU investment decisions need to align to these in future. The strategy also outlines the RFU's core activities which form the backbone of our business operations and services to the game. They fall into three areas: core rugby activity, core commercial activity and running the business. The community game is the lifeblood of our sport and it needs simple, focused support that delivers real benefit. This will include support to become commercially innovative and self-sustaining, the introduction of campaigns and programmes to attract new audiences to the sport, facilitating change that improves the enjoyment and safety of the game and guidance on increasing diversity in club leadership and playing bases. Creating a high-performance system that is committed to excellence is a priority that will aid our goal of producing consistently winning England teams through talent identification and development. We will achieve effective, integrated pathways for players, coaches and match officials and influencing the shape of the game domestically and internationally.

The target that would link carefully to the PPS agenda would be to establish "Flourishing Rugby Communities" this is defined by helping clubs to support / sustain and grow themselves and to reflect society.

- Provide support to club and CB volunteers so they can attract new, diverse volunteers and help clubs to be fit for the future and self-sustaining.
- Provide support to help clubs maximise the benefit from their facilities and assets.
- Help clubs to manage their risks and liabilities.

Our member clubs and Constituent Bodies remain the very heart of our sport. Their success determines our sport's success. It's where players first pick up a ball and develop a lifelong love of the game. Helping them to flourish both, as places for people to enjoy the sport and as businesses, is vital to a thriving game.

# 12.3 England Hockey

In 2017 England Hockey published the latest <u>facilities strategy</u> for the sport, which replaces the previous 2012 edition and aims to help every hockey club in England work towards having appropriate and sustainable facilities that provide excellent experiences for players.

**Vision**: For every hockey player in England to have appropriate and sustainable facilities that provide excellent experiences for players.

Mission: More, Better, Happier players with access to appropriate and sustainable facilities

The club market for hockey is well structured and clubs are required to affiliate to England Hockey to play in community leagues. As a result, only a few occasional teams lie outside of the EH affiliation structure. Schools and Universities are the other two areas where significant hockey is played.

England Hockey has the ambition of growing participation by 10,000 adults and 32,500 children. To enable this, the following three objectives have been highlighted;

**PROTECT: To conserve the existing hockey provision**. EH currently has over 800 pitches that are used by hockey clubs (club, school, universities). We need to retain the current provision where appropriate to ensure that hockey is maintained across the country

**IMPROVE: To improve the existing facilities stock (physically and administratively)**. The current facilities stock is ageing and there needs to be strategic investment into refurbishing the pitches and ancillary facilities. There needs to more support for clubs to obtain better agreements with facilities providers & education around owning an asset.

**DEVELOP: To strategically build new hockey facilities where there is an identified need and ability to deliver and maintain**. This might include consolidation hockey provision in a local area where appropriate. Research has identified key areas across the country where there is a lack of suitable Hockey provision and there is a need for additional pitches. There is an identified demand for multi pitches in the right places to consolidate hockey and allow clubs to have all their provision catered at one site.

## 12.4 England Cricket Board

## England and Wales Cricket Board Inspiring Generations 2020-2024

The ECB's current 5-year plan Inspiring Generations was published in 2019. It sets out six clear priorities for how the challenges cricket faces can be tackled and states that it is a plan that can adapt and flex to the fast pace of change being seen in the sport, while respecting and protecting the valued traditions of the game and setting out how the next generation of fans can be attracted to the game.

Amongst the many important actions set out for cricket across the game, specifically in relation to pitch provision and use, the strategy includes actions such as:

- invest in club facilities
- install non-traditional playing facilities in urban areas
- double cricket participation in primary schools
- deliver a compelling and coordinated recreational playing offer from age five upwards
- grow the base (in girls' and women's cricket) through participation and facilities investment
- launch centres of excellence (for girls' and women's cricket) and a new elite domestic structure
- deliver a girls' secondary school programme
- double the number of volunteers in the game
- increase participation in disability cricket

The strategy's aim is that by 2024, there will be a generation which will be inspired to say that "cricket is a game for me".

The ECB is responding positively to the impact of coronavirus on its sport. It has said that;

"The COVID-19 pandemic has left cricket facing its most significant challenge of the modern era. The game has already lost more than £100m, and the financial impact is likely to be £200m if there is further disruption next year, which many are expecting. Getting cricket back on this summer (2020) – at a recreational, domestic and international level, for both men and women – has been a remarkable achievement by everyone across the game. It has been the result of true partnership in action; across our first class counties and recreational game, from our broadcast and commercial partners and with Government and local public health agencies.

"Whilst the general provision for Oxfordshire cricket is generally met at recreational level we recognise that further growth will require there to be more 'affordable and available' collaboration with the education authorities. This will be a feature of the forthcoming Oxfordshire Cricket Board Facilities Strategy alongside wider community involvement, including growing the Women & Girls and pathway cricket. Equally the Oxfordshire Cricket Board requires a centre (ground and cricket centre) which enables it to grow its pathway and elite programme, meet the standards of National Counties Cricket and perhaps become a regional centre for women's cricket. Whilst at the same time acting as a community hub and providing additional facilities for club cricket".
