The Oxford City Council ("the Council") in exercise of its powers under Sections 32, 35 and 124(1)(c) and (d) of the Road Traffic Regulation Act 1984 as amended ("the Act of 1984") and of all other enabling powers and with the consent of the Oxfordshire County Council in accordance with Section 39(3) of the Act of 1984, intends to make the above Orders.

The effect of the Orders will be to revoke the City of Oxford (Off-Street Parking Places) Order 2011 in its entirety and all variations and subsequent amendments to it.

The proposed Orders will adopt the same provisions with regard to the operation of the car parks and enforcement and in relation to payment of charges and other conditions that are contained in the 2011 Order.

Three car parks will be added to the schedule of car parks designated as off-street parking at Headington Hill, Bury Knowle and Rose Hill Community Centre and tariffs for parking will be introduced at these car parks.


The proposed changes referred to above require the council to make a new order and it is proposed that three separate orders are made which reflect car parks in the city centre, urban and suburban areas of Oxford City.

At a meeting of the Cabinet on 12th June 2024 it was resolved that three new orders be made in accordance with any statutory requirements to achieve better management of the Council's car parks, to extend the schedule of car parks to include Headington Hill, Bury Knowle and Rose Hill Community Centre and to charge for parking at these locations.

Under the Local Authorities' Traffic Orders (Procedure)(England and Wales) Regulations 1996 the council is required to publicise the proposals.

Accordingly, full details of the proposal are contained in the draft Orders which may be seen, together with a Notice of Intention and this Statement of the Council's reasons for proposing to make the Orders at the Council's main office at the Town Hall, St Aldates, Oxford, OX1 1BX between the hours of 10am and 5pm Monday to Friday (excluding bank holidays and public holidays). The documents may also be viewed on the Council's website at www.oxford.gov.uk.

Any objections or other representations relating to the proposed Orders must be made in writing and should be sent to Oxford City Council, Parking Service, PO BOX 10, Oxford, OX1 1EN and by email to carparks@oxford.gov.uk by no later than 17.00 **16/10/25** . All objections or other representations must specify the grounds for their objection.
